

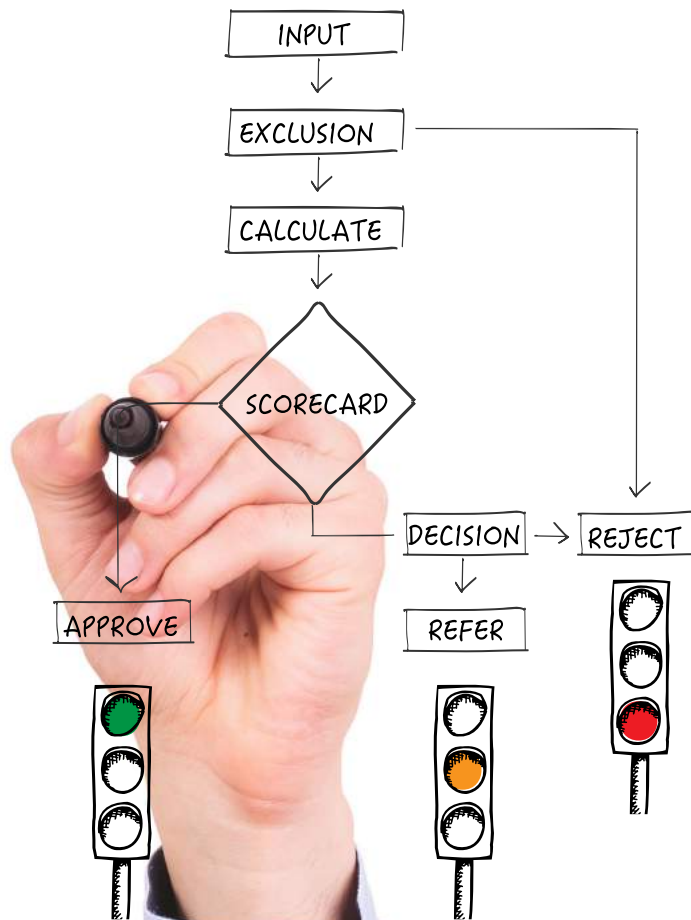

- Collections (strategies to manage delinquencies effectively)

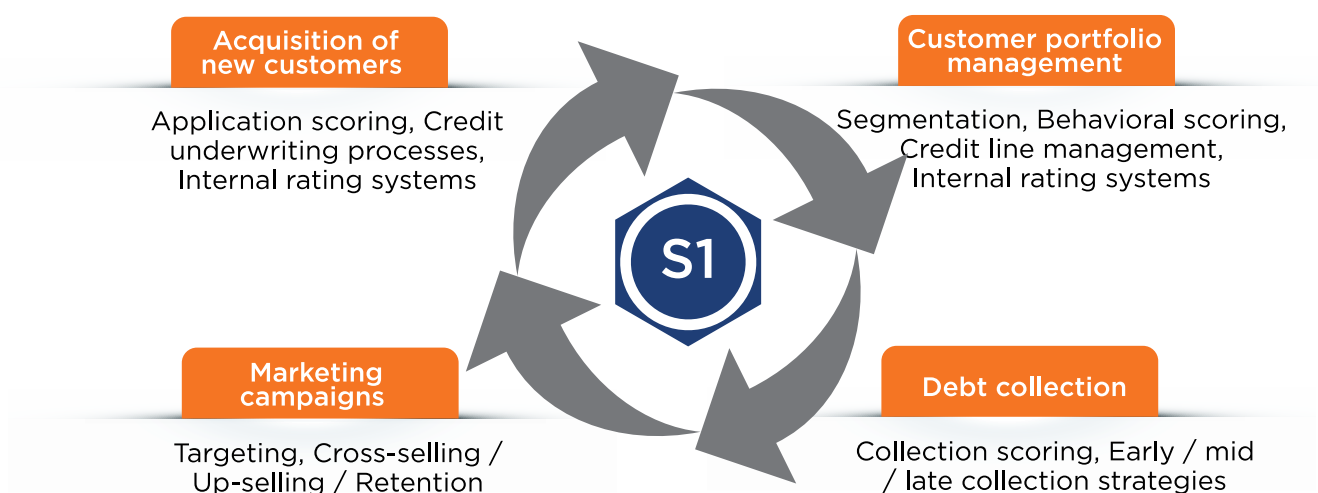

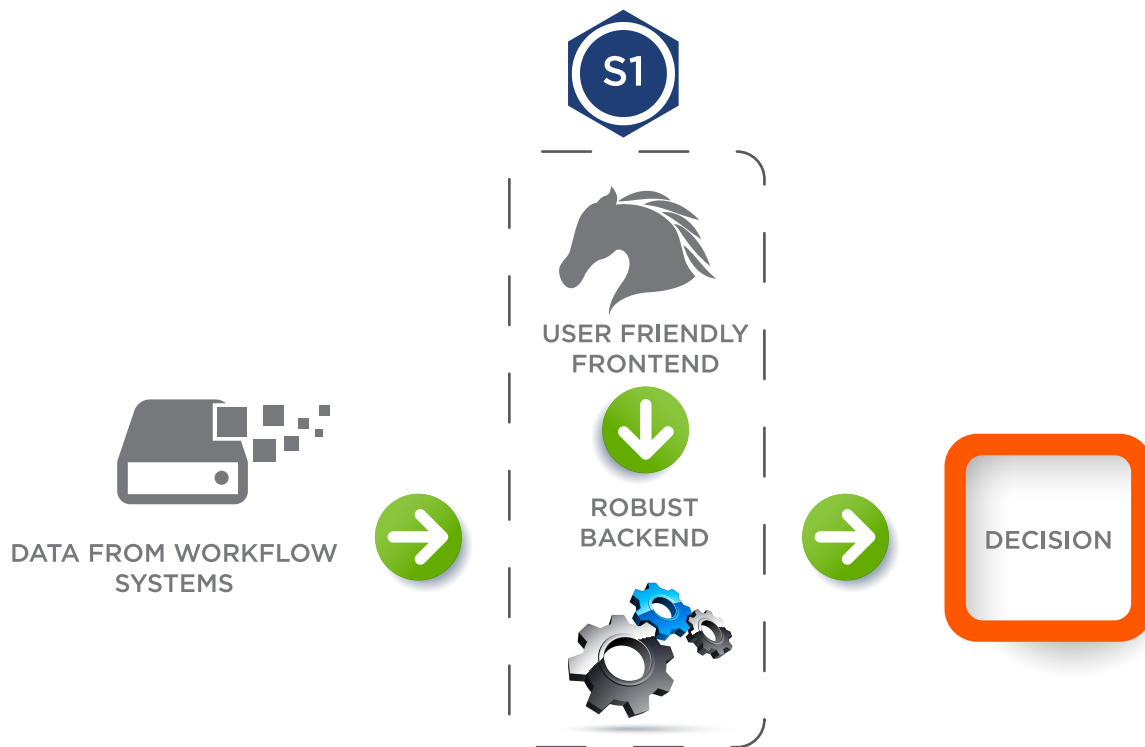
